Electoral Appeals for House of Representatives Candidates 2020

October 2020

Report of Forum of Development and Human Rights Dialogue



Introduction

According to the schedules announced by the National Elections Authority, voters were invited to vote on Thursday, September 10, 2020 and applications were scheduled to be received and examined for 10 days, from September 17 to September 26, 2020 and the candidates' lists and symbols were announced and appealed to the Administrative Court for three days from September 27-29, 2020. The Administrative Court has dismissed the appeals in accordance with the date of the schedules announced within three days from September 30 to October 2, 2020.

The National Elections Authority, headed by Chancellor Lashin Ibrahim, Vice-President of the Court of Cassation, officially announced the final list of candidates for the elections to the House of Representatives, after completing a review of all rulings issued by the Supreme Administrative Court of the State Council. The final list of candidates in the House of Representatives elections included 4,032 individual candidates and eight lists of the list system. The deadline for dropping out was October 7, 2020, when the National Elections Authority received nearly 40 concessions within the time limit for receiving concessions.

It is known that the Parliament elections' law and its amendments state that "each candidate shall waive the candidacy by declaration, by a report or by any other official means specified by the National Elections Authority and the candidate may waive the application to the Electoral Process Follow-up Committee of the specialized magistrates court's district, and the waiver shall be at most 48 hours from the date of the announcement of the final list of candidates, and The waiver shall be recorded in front of the candidate's name in the list of candidates in the district if he was registered in this list."





"It is also permissible to amend or waive the nomination of the list candidates by applying to the National Elections Authority from the representative of the list within 48 hours at most of the date of the announcement of the final list of candidates, and the Authority shall publish the waiver in two widespread daily newspapers the day after the expiry of the scheduled date of the waiver, and announce the waiver of candidacy on the day of the election at the door of the subcommittees."

The elections are held in the first phase in the districts of 14 provinces of the individual system: "Giza, Fayoum, Beni Suef, Minya, Assiut, El Wadi El Gedid, Sohag, Qena, Luxor, Aswan, Red Sea, Alexandria, Beheira, and Matrouh."

While in the list system, elections will be held in the first phase for the second district "North, Central and South Upper Egypt", based in the Giza Security Directorate, including 11 governorates (Giza, Fayoum, Beni Suef, Minya, Assiut, El Wadi El Gedid, Sohag, Qena, Luxor, Aswan, Red Sea), 100 Seats had been dedicated to it, as well as in the fourth district "West Delta Sector" and based in the Alexandria Security Directorate, including 3 provinces (Alexandria, Lake, Matrouh), and 42 seats had been dedicated to it.

On October 21, 22 and 23, abroad, October 24 and 25 at home, and in the event of a run-off at this stage, elections will be held on November 21, 22 and 23 abroad, and November 23 and 24 at home.

The second phase is the elections for the House of Representatives by individual system in 13 provinces: "Cairo, Qalyubia, Manoufia, Daqahliya, Al-Gharbia, Kafr Al-Sheikh, Sharqiya, Damietta, Port Said, Ismailia, Suez, North Sinai, and South Sinai."





In the list system for the second phase, elections will be held in the first district, based in the Cairo Sector Department and south and central Delta, and based in the Cairo Security Directorate and includes 6 governorates (Cairo, Qalyubia, Daqahliya, Menoufia, Al-Gharbia, Kafr al-Sheikh), and dedicated to them 100 seats, as well as in the third district "East Delta Department" based in the Eastern Security Directorate, which includes 7 provinces (Eastern, Damietta, Port Said, Ismailia, Suez, North Sinai, South Sinai), with 42 seats dedicated.

During the days of November 4, 5 and 6, abroad, and on November 7 and 8 at home, and in the event of a run-off at this stage, elections will be held on December 5, 6 and 7 abroad, and on December 7 and 8 at home.

Electoral Appeals

Following is a review of the electoral appeals witnessed by the courts of the State Council and what has been done with the results, starting with the appeals monitored by a number of different provinces in the courts of the State Council, and all electoral appeals have been monitored by the Supreme Administrative Court of the State Council. The most prominent of which were:

- Lawsuit No. 62078 of 74th judicial year On October 4, 2020, the Supreme Administrative Court of the State Council ruled that the case filed by Hisham Mahmoud Mohammed, a lawyer for the supreme court, and an agent for Mustafa Al-Shahat Ahmed Sultan, would not be accepted, demanding that the Decision of the National Elections authority No. 52 of 2020 call on voters to elect members of the House of Representatives, as a result for being filed after the due date of the cases to be filed.
- The exclusion of "Saeed Hasasin" from the electoral race for the issuance of final criminal judgments against him.



- - The appeal of two brothers against each other's' candidacy for the same constituency and the number of appeals reached more than 10. The Supreme Administrative Court returned Sayed Hanafi Taha "Individual Independent Cairo" to the election race, after he and his brother Jamal Hanafi Taha were excluded, after they appealed to the Administrative Court against each other, each filed five appeals against his brother, all of which included charges of reputation and criminal judicial decisions against them.
 - The Supreme Administrative Court also ruled that the appeal by Member of Parliament Dia' aldiyn Dawud to rule him out of the 2020 parliamentary elections was accepted.
 - The Supreme Administrative Court of the State Council, with regard to the women's quota, rejected a lawsuit to stop the implementation of the passive decision that the National Elections Authority refrained from determining the quota for women in 142 out of a total of 143 constituencies in the Arab Republic of Egypt, it also ruled in the second request demanding the cancellation of resolution 54 for the year 2020 that it does not accept to raise it after the date. The lawsuit was filed by Amal Abdul Rasul Hussein Abdel Naim, a candidate for the Parliament of the individual system, in which she demanded the annulment of the passive decision that refrains from specifying the quota, which according to the number of districts represents 25% of the quota of women in accordance with the Egyptian Constitution of 2019 and demanded that Egyptian women in each electoral district be granted the right to run on quota in accordance with the constitution in which article 1 and 2 stated, taking into account the fair representation of the population and provinces and the principle of equal opportunities.
 - Lawsuit No. 1687 of 57 judicial year, in Luxor governorate, the Court of the State Council received a lawsuit to suspend the implementation of the decision



to the 103 department (individuals) in Luxor, despite the completion of the Supreme Administrative Court of the State Council, from the consideration and decision of appeals filed before it, and the sending of rulings to the National Elections Authority to prepare the final lists of candidates, the suit demanded a stay of implementation of the decision to form the 103 department (individuals) in Luxor.

First: Appeals by the Administrative Court of Justice

The topics of the lawsuits considered by the court included between a candidate challenging the non-acceptance of his candidacy papers by the National Elections Authority, while other lawsuits included an appeal against not including the names of some applicants in the lists of candidates despite their papers being accepted by the committee, as well as appeals due to drug analysis, housing addresses and non-performance of Military service. The appeals that were monitored by the Collation Elections Observatory at the Forum for Development and Human Rights Dialogue, in the courts of the State Council in the governorates of "Cairo, Giza, Qalyubia, Alexandria, Minya, Kafr El-Sheikh, and Luxor" are as follows:

- On October 2, 2020, the State Council Court in Cairo rejected 139 cases demanding the inclusion of candidates, and ruled that 5 candidates should be accepted and returned to the elections after being excluded by the application examination committee.
- In Kafr Al-Sheikh governorate, on Thursday, October 1, 2020, the Administrative Court rejected the appeals of 4 candidates who were excluded by the committee examining the papers of candidates applying for the elections to the House of Representatives, in the Kafr





Al-Sheikh Municipal Court, and accepted the appeal of another candidate on the modification of his name of fame, and the court accepted an appeal to amend the name of one of the candidates, and put his moniker on the candidates' lists.

- In Qalyubia Governorate, the Administrative Court of the State Council decided, Thursday, October 1, 2020, to accept the appeal of two candidates excluded from the electoral lists, in addition to rejecting 8 other appeals for not completing the papers related to the conditions of candidacy. Banha Municipal Court announced the exclusion of 17 potential candidates from the electoral lists of the House of Representatives, due to the incompleteness of the necessary conditions for them and 3 of them testing positive for drugs. The examinations they conducted in the hospitals announced by the National Elections Authority, in addition to the incompleteness of the papers or the receipt of the results of the analyzes conducted by some candidates.
- In Minya governorate, on Saturday, October 3, 2020, the department rejected 83 members of the Administrative Court of Justice in Minya, 6 appeals for the upcoming 2020 parliamentary elections.
- In Alexandria province, on October 4, 2020, the Administrative Court ruled that 37 appeals by the candidates of the House of Representatives had been rejected, while three other candidates had been returned to the elections after accepting appeals to the Administrative Court of Justice.
- In Luxor Governorate, on October 7, 2020, the Administrative Court rejected five appeals submitted by the excluded candidates, who had been excluded by the Paper Examination Committee of the Luxor Court for not completing their papers.



Second: Electoral appeals before the Supreme Administrative Court for candidates for the House of Representatives elections 2020 (first district)

The report monitors all electoral appeals that were considered by the Supreme Administrative Court of the State Council in Cairo, in which it ruled that 156 appeals were rejected, 84.5% of the total number of "185" appeals that were monitored. The reasons for rejecting the appeals submitted by the candidates varied between criminal judgments against them or because of their positive drug tests, and other reasons related to the form for not completing the papers, or not performing military service, while it referred 15 appeals to the trial court, at a rate of 8%, and ruled to cancel the contested decision in 14 appeals, at 7.5% of the total that was monitored,


