Monitoring the status of domestic workers in Egypt

This monitoring will be divided into two sections:

First, the offending domestic workers.

Second: Victims domestic workers.

The offending domestic workers.

- (1) “N.B.”, a 33 years old actress has filled a report to the Police Department in El-Nozha. In this report, she accused her first maid with 46 years living in Hadayek El-Qubba and her second maid with 40 years living in in Ain Shams, of stealing her expensive shoes which cost 2750 pounds and sums of three thousand pounds, and some gold jewelry from inside her apartment located in the New Nozha neighbourhood. The two maids were arrested and, by asking them, denied that they had committed the incident.
- (2) The maid of the actress Ilham Shahin, who is called “A.M.”, had stolen some gold Jewelry and mobile phones from inside the artist's apartment and then fled to her family home located in the Ajmi area of Alexandria. The Al-Atarin investigators were able to arrest the maid and returned the stolen items to the actress Ilham Shahin. And the Public Prosecution ordered the detention of the maid pending investigations.
- (3) “Y.S.M.”, “21 years old,” stole “3,700 pounds” and some gold jewelry from inside the house in which she works as a maid, which is the house of the artist, “Magda Al-Sabahi,” which is located in “Okasha Street in the Dokki neighborhood.” And she fled to her village, "Shebeen El-Kom", and the maid was arrested and confessed the theft and was instructed about the location of the stolen items. And the Dokki Court of Appeal for Misdemeanors decided to punish the maid with imprisonment for a period of

“6 months”, after a first court ruling imprisoning the maid for a period of one year..

- (4) The maid who works in the house of the artist “A.M.” stole gold and silver jewelry and clothes worth “10 thousand pounds” from inside the house, then she fled to her village in “Kafr El-Sheikh” governorate, and the detectives were able to arrest her The maid who confessed to stealing artifacts from the artist's apartment in Agouza, and she was referred to the Public Prosecution.
- (5) The maid of the artist M.F. has stolen investment certificates from within her own closet worth "140 thousand pounds" and then disappeared, and his two sons discovered the theft four days after the maid disappeared.
- (6) “H.M.L. a 28 years old girl exploited her sister's work. Her sister H.M.L. aged 23 years old, working with the actress A.M. that is studying at Pyramid Music Institute and living in Maadi neighbourhood. The old sister has stolen her sister after the second had left her work with the actress. She planned to steal her by the aid of the 29 years old painter “Sh. A. H.”.
She persuaded the singer to work for her as a maid and gave her a photo of a personal card by a name other than her own and took the painter with her as the owner of a maids' employment office, after three days of work, she stole: Gold jewelry, \$ 40 thousand, 36 thousand pounds and mobile phone from the singer’s apartment. The accused were arrested and confessed to the crime.
- (7) A Nigerian maid named "S.H." a resident of Nasr City, has sent a message via telephone to the artist “M.A.” the resident of Zamalek. The maid has threatened to harm her and her son. The maid worked for the artist and left her work. The artist wrote a report No. 5658 at the Qasr al-Nil section, in which she demanded proof of the case and legal action against the maid.

- (8) “ H.A.A.”, a 17-year-old maid, has stolen an amount of 6,000 pounds from the villa of the former football player in Zamalek club, J.A., who is currently working as a coach, which is located in Al-Shorouk city, where she made a copy of the key to the iron treasury in the bedroom, then she stole the amount at intervals, and she was arrested and found in her possession an amount of “3700 pounds.” When asked about the rest of the amount, she said that she had bought a mobile phone and some clothes, and she was referred to the prosecution.
- (9) The maid who works for the artist "R.M.I" stole a golden ring encrusted with a diamond lobe, worth 50 thousand pounds, from inside the artist's apartment located in the Al-Omraniya neighborhood, and then she pledged allegiance to a jeweler in Kafr El-Sheikh governorate, in which the maid's family resides. The jeweler smashed the diamond lobe, which was estimated at 10 thousand pounds, believing that it was glass, and they were referred to trial after they confessed the incident.
- (10) The artist, "S.K.", residing in Al-Agouza neighborhood, accused her maid of stealing an amount of 30,000 pounds from inside a cupboard in her bedroom. The maid, who denied the theft, was arrested and insisted on denying it, so Al-Agouza Prosecution released the maid with a guarantee of her place of residence. Two years before this incident, that is, in 2003, the artist herself was subjected to the theft of jewelry and jewelry estimated at 60 thousand pounds by her maid as well, and the maid was arrested and the stolen items were returned to the artist.
- (11) The Lebanese singer "J.R," the wife of the Lebanese singer "W.T," accused three maids working for her in her apartment, located in Agouza neighborhood, of stealing gold artifacts and jewelry, including a diamond ring, the price of which is estimated at ten thousand pounds, from inside her

apartment, and after the arrest of the three maids, they denied that they had committed the theft and said that it was a false claim that there was a dispute between them on the one hand and the artist and her singer husband on the other. The maids were released from the prosecution of the old woman.

- (12) The maid, "SH.H.B", who works in the house of the artist, "SA", stole ten thousand dollars from the artist's cupboard, and the maid, who confessed to the theft, was arrested and said that she had committed the theft after instigation from her fiancé, H.M., who works as a plumber, was arrested to complete their marriage, but they only returned 18,000 pounds out of the amount of 65,000 pounds, as they spent the rest of the amount in paying the rent for an apartment and buying electrical appliances and depositing an amount of 10 thousand pounds in a savings book in the name of the maid's fiancé, and the artist filed a lawsuit demanding that she return the stolen sums.
- (13) The artist "A.M." accused two maids working for her in her apartment located in Kerdasa of stealing an amount of 80,000 pounds and jewelry worth 150,000 pounds from inside her wardrobe. After the two maids were arrested, they denied the theft, and it became clear, two weeks after the incident, that the thief was a driver who used to work for the artist for a while, and he broke down the door of the apartment, stole money and jewelry, and sold them to a jeweler in the Bulaq al-Dakrouir neighborhood.
- (14) The artist "A." accused his maid who is 40-year-old that she had stolen a sum of 4 thousand pounds from his apartment on Suez Bridge Street. The maid who denied the theft was arrested, but she pledged to return the sum to the artist in order to preserve her reputation after borrowing from her relatives.

- (15) This incident occurred in 1997 when the maid "M. M.L. A " who worked for the late artist "A.M." house in Al-Doqqi, she escaped and was sentenced in absentia to three years' imprisonment. She was arrested in 1999, retried and sentenced to imprisonment with work.
- (16) M.A.M., a resident of the Bulaq Al-Dakrour neighborhood, and her sister is a servant who works for "N.R", the owner of a furniture showroom residing in Manial, took advantage of her sister's work and went to the house where she works on her sister's day off and deluded She told the owner of the house that she would serve him instead of her sister, then she fell on his head with an iron piece and stabbed him with a knife, then she seized an amount of two thousand pounds, a golden bracelet, and two mobile phones, and she was arrested and referred for investigation.
- (17) Two maids tried to kill a wealthy woman in her sleep to steal her golden works, then cut off the power and escaped. The crime took place in the village of the President of the Naja Hamadi Centre in Qena governorate and they were arrested and referred for investigation.
- (18) The maid " Q. m. "Stealing the sum of 20 thousand pounds and golden works from the apartment of " m. ", the owner of a company in Al-Doqqi neighbourhood, but the owner of the house did not discover the theft until 7 months after its commission and after she left for work, she was arrested and returned the stolen items.
- (19) The maid " M.H. who is 26 years old and "T. a." who is a 29-year-old painter, has stolen gold jewelry of 18 gold ring and 34 gold crown plus a sum of 30 thousand pounds from inside the house of "S. H. A." who is an engineer of Petroleum Company with which the maid works. The maid used her work at home and obtained an artificial copy of the keys to the house and gave it to her husband who managed to enter and seize the stolen items in

the absence of the homeowner. They were arrested and instructed on the stolen items that had been held by a jeweller in the city of Al-Salam.

- (20) The maid "Sh. A." Stole golden jewelry which are 6 rings, 8 earrings, 4 cascades and 4 chains, plus a sum of 15 thousand pounds from inside the apartment of "M. S. M." who is an Employee of the Free Markets Company, using her work as a domestic servant. After her arrest, she found the golden jewelry and admitted that she spent the money buying electrics.
- (21) A maid and her sister called "N.A." agreed to steal the jewelry of a 9-year-old child. The maid used her work for the child's family in the urban neighbourhood. Her sister abducted the child on her way back from school and took her to Alexandria. She sold a gold earring and a ring that the child had for 200 pounds. She returned to her village with Fayoum. She was arrested and returned to her parents.
- (22) The maid "M. M. S." exploited the disease of its served "M. M. B." who lives in the neighbourhood of the caliph and tried to kill her by mugging her breath to steal half a kilo of golden jewelry belonging to her served. When the lady cried, the maid escaped, accompanied by the golden jewelry, she was arrested and guided from where the jewellery was sold.
- (23) The maid "R. F. GH." stole a gold ring with diamond cloves valued at 20 thousand pounds from its served in Nasr City, after she had flinched. She was arrested while frequenting aesthetic shops to sell the ring and was returned to the victim.
- (24) The gardener "M.H.S." stole the solitaire ring with diamond cloves and a platinum mill and diamond cloves from a businessman's villa in Sheikh Zayed City where he works. He was arrested during his attempt to sell the stolen items, estimated at 100 thousand pounds.

- (25) A maid stole a "diamond ring", the price of which is estimated at "70,000 pounds", from her employer, "A.M.A", who lives in the Maadi neighborhood, and tried to sell it to a goldsmith's shop in Al-Gamalia for a very low price, and she was arrested while receiving it. In exchange for selling the ring, it was returned to the victim without issuing a report against her.
- (26) The maid "A. M." 28 years stole 36 thousand pounds from inside a translator apartment and the owner of a garment factory in Al-Doqqi. As she frequented this apartment for work once a week, she stole the sum of 2,000 pounds the first time from a bedroom cupboard, and that's because she's in financial distress and she wants to get ready for marriage. When things went normal, she stole several sums at intervals until she reached 34 thousand pounds. After the husband of the translator discovered the theft, a dispute arose between them. The husband's suspicions went to the college student's daughter, which prompted the translator to learn the truth when she placed 200,000 pounds inside the bedroom. It created all the conditions for the maid to steal, and the maid actually stole the money. When the translator checked her, she found the money hidden inside her clothes. She reported the incident to the police and the maid was handed over.
- (27) The maid "S. S. H." 21 years old stole her served "Sh. M. M. who is 41 years old in several stages from her apartment in Maadi where she stole the sum of 20 thousand pounds, 5 gold pounds, 6 rings, 2 neckless and 2 bracelets, one diamond and 3 watches and television, the maid was arrested and guided about the location of the stolen, and she was referred to the prosecutor.
- (28) A maid killed her servant "A. E. Sh." Who is 56 years old and she is also an officer of the Criminal Investigation Department, after stealing her golden

jewelry and some cash, after she put a plan jointly implemented by her son "A. M. A." who is 21 years old and his friend "A. G. A." who is 20 years old. When they seized the stolen items they collapsed the victim's head with an iron barrel and fled. The accused were arrested in a village in Beni Suef governorate and the incident took place.

- (29) The 14-year-old maid "H. S. A." killed the five-year-old child "N. A. M." who lives in the same house as the maid, after stealing her golden earring, so that she could buy a newer mobile phone, where she removed the earring from the child's ears. When she cried for help, the maid held her breath and grabbed stones and smashed her head. Then the maid told her mother, "N.A.M.", 42 years old, of the incident, and she advised her to wait until the evening to hide the body. They threw her into the neighbour's house. The maid was arrested and charged with murder in conjunction with forced theft. Her mother was charged with co-concealment.
- (30) The 22-year-old maid, "S.H.A.", stole a box of jewelry belonging to her 50-year-old served, who was working as a teacher in a Gulf country, and her husband was working in an oil company in the same country, and he was arrested. The maid was preparing to travel to a Gulf country to work as a maid through one of her relatives in the village of Abu Al-Numros, Giza Governorate, where she confessed that she had committed the theft in revenge for her employer's mistreatment and torture of her, as she was instructed about the location of the stolen items. \
- (31) Each of the two maids, "H.A.A." and "A.A.M.," stole gold jewelry and an amount of 10,000 pounds from the apartment of their employer, "M.A.M.," the owner of a company employing his workers and lives in the Helwan neighborhood. They were arrested and showed the whereabouts of the stolen items.

- (32) A 30-year-old maid and her 33-year-old unemployed lover stole the contents of the apartment of the owner of a company in Nasr City neighborhood, in which the maid works. During the execution of the crime, they were surprised by the presence of the owner of the apartment, so they tied him with ropes from his feet, and they were arrested near from the victim's house, where they were carrying a TV, and they were found in possession of 5 thousand pounds and some gold artifacts.
- (33) A maid named Duha, with the help of two unemployed youths and a broker, killed and robbed her employer, "A.H.", 30 years old, an Iraqi, in his apartment in the Al-Agouza neighborhood, where they tried to steal him, and when they failed, they strangled and tied him up and fled on the run.
- (34) The 29-year-old maid, T.R.A., who resides in the eastern district of Al-Husseiniya, stole an amount of 9 thousand pounds from the apartment of her employer, "N.A.", the former head of the State Information Service and the managing director of the Media Production City in the Maadi neighborhood, and she was arrested And she confessed to the crime of theft and instructed about 4300 pounds and confirmed that she spent the rest of the amount to pay off her debts.
- (35) The 35-year-old maid, N.F.A., stole gold artifacts consisting of 6 bracelets and a set of golden rings from her employer, who is the wife of a lawyer. She was arrested while trying to sell the stolen goods at a cheap price, as someone advised her The owners of jewelry stores, and she confessed to the theft and justified that because she was going through financial hardship. The Al-Darb Al-Ahmar Misdemeanor Court issued a ruling to punish the maid with imprisonment for a period of 6 months with work and enforcement.

- (36) The Ugandan maid, "S.W.," agreed with "A.K.," who is also a Ugandan, to kidnap a 10-year-old child, who is the son of the businessman for whom the Ugandan maid works, from the villa in which he lives in the "King Mariout" area. Where he entered the villa and hid the child inside one of the rooms after a gag so that he could escape with him to Cairo, in an attempt to blackmail his father, a businessman, and obtain from him an amount of 100 thousand dollars. The child was found and kidnapped inside the villa before he could escape.
- (37) A maid stole a golden bracelet with diamond lobes, the price of which is estimated at a quarter of a million pounds, from her 74-year-old servant, "Z.A.H." She is a housewife residing in Heliopolis, and the maid was arrested while trying to sell the bracelet at a price that is not commensurate with its value. Where one of the owners of jewelry stores in Al-Jamaliyya reported her and she confessed to the crime and was referred to the Public Prosecution.
- (38) (38) An 18-year-old maid kidnapped the two-year-old "M.G.A.," the son of a real estate guard on Claude Bey Street in the Moski neighborhood, believing that the father of the child was the reason for her expulsion from the house in which she used to work in the same property in which he works. And the child was found with a broker, where the maid gave it to him to sell to one of the barren women, and the maid and the broker were arrested.
- (39) A maid stole an amount of 18 thousand pounds and gold artifacts estimated at 4 thousand pounds from the house of her employer, the head of the Zagazig Court of First Instance in New Cairo, and she fled after discovering the theft.
- (40) The 43-year-old maid "H.H.A.", in agreement with her husband "MA.A.A", who is 44 years old, is a day laborer, and his friend "A.A", who is 25 years

old and is a plumber, planned to kill her maid. F.M.A., who is 68 years old and resides in Al-Sahel neighborhood, so that she can have access to all the contents of the house, and the defendants were arrested while committing their crime inside the house after a person reported them, as they offered him their participation in the commission of the crime, and the maid admitted that she had previously And if she stole some gold jewelry and sums of money more than once and did not discover the theft, then she wanted to carry out a major operation to seize all the contents of the house.

- (41) The 20-year-old maid "A.S.A." killed her newborn girl by throwing her from the fifth floor of the property in which she works in the Sidi Gaber area in Alexandria, where she was afraid of a scandal after she carried a butcher from a person called Ahmed, where he lived. In Giza, she used to work for him, and she did not know any information about him, and he disappeared.
- (42) Maid Fatima stole 13 thousand United States dollars from inside her served apartment. "M. L. A." 54-year-old housewife who stole them from the bedroom cupboard, was arrested and confessed to stealing and returning the stolen.
- (43) The 19-year-old maid "A.M.A." stole a golden ring encrusted with diamonds from the house of her employer, "RAB," in Al-Sahafiyeen City, Mohandessin, and tried to sell it to a jewelry store in Al-Gamalia for a price that was not commensurate with its price. By reporting her, she confessed to stealing the ring because she wanted to consummate her marriage.
- (44) The maid, Umm Hashem, stole an amount of 9 thousand pounds from the house of her employer, "A.M.", a pensioner and resident in Assiut Governorate, and she was arrested and confessed to the theft because of her desperate need for money, and that she spent 6 thousand pounds and returned the remaining amount 3 thousand pounds

- (45) (45) The 37-year-old maid, H.R.G., stole an amount of 3 thousand dollars and another amount in Egyptian currency from the house of her employer in Alexandria, who works as a consul for an Arab country, who confirmed that the surveillance cameras had revealed that the maid was behind the theft of those amounts.
- (46) The 23-year-old maid, H.M.A., who resides in Warraq Al-Arab, Giza Governorate, stole an amount of 1,300 euros and 200 Egyptian pounds from two officers of the Austrian Federal Investigation, from their residence in Zamalek, as they belong to the Austrian Ministry of Interior and are assigned to Egypt is on an official mission in the Egyptian Ministry of Interior, and the maid who confessed to the theft was arrested and admitted that she had bought some gold jewelry and a mobile phone, and she was punished by imprisonment for 6 months with work and a bail of 1,000 pounds.
- (47) The 35-year-old S.P.A., an employee of the American Embassy and a resident of the Al-Nuzha neighborhood, accused her 23-year-old maid, a resident of Hadayek Al-Qubba, of stealing a large amount of gold artifacts, including chains, earrings, chains, and pendants. And two mobile phones and other belongings worth 40 thousand pounds, and that when she searched her, she found part of the stolen items in her handbag, and the maid denied that she had committed the theft, and said that her employer was the one who put the stolen items in her handbag, but she did not justify that.
- (48) The maid, "A.A.M.", who holds a trade diploma, stole gold jewelry, 2 diamond rings, and a mobile phone, valued at half a million pounds, from the house of her employer, "S.A.M.", director of the Commonwealth Support Fund at the Ministry of Foreign Affairs, located in Giza Street, Cairo Governorate. The maid was arrested, accompanied by her boyfriend,

while they were trying to sell the stolen items in Al-Attarin area, Alexandria Governorate.

- (49) The 33-year-old maid, "Z.A.," stole an amount of 15,000 pounds and some gold jewelry worth 5,000 pounds from the house of her employer in the Al-Omraniya neighborhood, who works as an engineer. She was arrested and confessed to the theft, and that she had bought electrical appliances and a TV. And a video, cassette and receiver, and she gave the rest of the money to her husband.
- (50) The 21-year-old maid, "S.M.M." stole "golden artifacts" from the apartment of her 36-year-old employer, "D.M.M." She works as the secretary of the former business minister and lives in Al-Umraniyah. The maid was arrested in her home. in the island of gold in the governorate of Giza, and I was instructed about the stolen items.
- (51) The 24-year-old maid, M.A.A., stole a chain, a golden watch, and some artifacts from the home of her employer, "A.Sh.," who is a lawyer in Qasr al-Nil. She was arrested and confessed to committing the crime.
- (52) (52) The 18-year-old maid, "N.F.Q", kidnapped the child of her employer, "F.A.M.", who is 25 years old and 11 months old, while his mother left him in Ahmed Maher Hospital with the maid. The maid was arrested and She had the child with her at the Egyptian station, where she intended to take him to Alexandria to use him for begging.
- (53) The maid, Umm Hashim, stole an amount of 100,000 pounds and jewelry estimated at half a million pounds from the house of her employer, a businessman in the Mohandessin neighborhood. The maid was arrested at the Dalangat station in the lake where the maid and her family reside, and she said that she had met a young man in her town. In the lake, he deluded her with love and that he would marry her, but he did not have enough to

propose to her family and persuaded her to steal. In fact, she stole the key to the bedroom cupboard, and after the owner of the house and his wife left, she opened the cupboard and stole all the money and jewelry in it.

- (54) The 40-year-old maid, "F.M.M.," stole a solitaire ring from the home of her 40-year-old employer, "A.A." She tried to sell it in a jewelry store in Al-Gamaleya for 20,000 pounds, which is a price that is not commensurate with its value. The owner of the shop reported her after he suspected her, and she was arrested, confessed to the crime, and said that she was stolen due to her financial hardship.
- (55) The Filipino maid stole (6,000 euros, 1,000 dollars, 4,000 Egyptian pounds, and a wristwatch) from the bedroom of her 68-year-old servant, the former head of the Radio and Television Union, located in her residence on Gamal El-Din Abu Al-Mahasen Street, in the Garden City neighborhood of Cairo, at the instigation of From a 27-year-old driver who used to work for the victim, after he deluded the maid that he loved her and that he would put her share in a foreign bank. saving in his name) and gave the bank driver (3 thousand pounds) to tell the maid that an account was opened in her name in the bank and (2500 pounds) was found in his possession.
- (56) The 48-year-old maid killed her 73-year-old employer, an engineer with a pension, at his residence in a villa in Ismailia, in order to steal an amount (50 thousand pounds and some electrical appliances), where she called her daughter (22 years old - a housewife) and then she prepared a cup of juice for the victim and placed it (Poison) The daughter seized the stolen goods, then sought the help of her 33-year-old daughter's husband, an electrician, to hide the victim's body. She cut the body into two halves. She (the maid) hid the lower part in a hole inside the villa, and her daughter-in-law threw the upper part in the desert. The Ismailia Criminal Court decided to refer the

maid's papers to His Eminence, the Mufti, and set a session (21/6/2007) to rule on the case.

- (57) The 45-year-old, who works as an announcer in the news sector on the first channel of the Egyptian TV, informed the Giza Investigation Department that he was surprised that (a digital camera and a sum of money of 700 pounds had disappeared from his apartment), then he discovered the disappearance of his 18-year-old maid, accompanied by her friend (Azza), and the maid was arrested and she confessed Theft and the prosecution is investigating.
- (58) (58) A maid set the fire in her serviced apartment, which works as a (school). The incident occurred in the first section of Al-Mahalla Al-Kubra, which resulted in the burning of its contents, including furniture and electrical appliances, in order for the maid to hide the traces of the crime of theft she had committed.
- (59) A maid for a deceased businessman in Alexandria made a forged power of attorney attributed to the deceased businessman for the maid, then she registered it with the knowledge of an employee of the real estate registry, and she sold (800 meters) of the businessman's property to the owners of a contracting office in Cairo, with whom she had previously agreed, where they registered the land and extracted Official certificates with which they filed a health and enforcement suit to prove their ownership of the land. A general attorney, the first public funds in Alexandria, referred him (the maid, the real estate registry employee, and the three owners of the contracting office) to the Criminal Court.
- (60) A maid stole (two bars, 5 golden pounds, 2 bracelets, 4 chains, two rings, and 3 pendants) from inside the villa of her 32-year-old female servant, a doctor, in Beverly Hills, Sheikh Zayed City. These stolen items were

estimated at one million pounds, and the maid was arrested by civil investigations on October 6 , Where the maid confessed to the theft and that she had sold the stolen items to a jeweler in Al-Buhaira Governorate, and he was arrested. The stolen items were returned to the doctor.

- (61) (61) A 22-year-old maid committed suicide by jumping from the balcony of her employer's house in Nasr City neighborhood after accusing her of stealing an amount (one thousand pounds) from the bedroom cupboard, which the maid admitted to and while signing a trust receipt for the amount so that her employer would not inform the police She surprised everyone by jumping from the balcony, to her death on the spot.
- (62) (Amal, a maid) stole an amount of 170 thousand pounds and gold jewelry worth 50 thousand pounds from the wardrobe of her employer, Hajj Lotfi, in his residence in the Haram neighborhood, then she hid the stolen items in a room she rented in the Talbiya neighborhood inside the house of expatriate women, and after an hour of hiding the stolen items she went To the Haram investigations to issue a report accusing her employer of attempting to rape her after she caused some injuries to her body, then Hajj Lotfy wrote a report accusing the maid of stealing it, and the investigations revealed that the maid's claim was to cover up the theft incident and that she falsely claimed an attempt to rape her from her employer to prove to the police that a report The theft, which was maliciously presented by her employer, and the maid admitted the fact and was referred to trial.
- (63) A maid working in the artist's house in the Dokki district stole an amount of 50 thousand pounds and a mobile phone from his son Sharif, after one day of working for him, and the maid was arrested and the prosecution took over the investigation.

Victims domestic workers

- (1) The singer "B.S", who is famous for her hot and sexy video clip songs, imprisoned her maid, "H.M", who is 15 years old, in her apartment in the Maadi neighborhood, where she closed the door of the apartment and left her for fear of her escaping, so the maid tried to escape from the balcony of the apartment On the third floor, she was using a bed sheet, so she lost her balance and fell, and she was killed instantly. The maid had asked the artist to leave work with her after one day of work, as the singer asked a maid from one of the service offices in Maadi on March 14, 2005, and the next day she asked her to leave the job, but she refused and told her that she would not leave her, despite the offer of the service office to replace her with another. In November 2005, the Basateen Misdemeanor Court sentenced the singer to one year's imprisonment with hard labor and a bail of 100 pounds. After appealing the ruling, the Basateen Misdemeanor Court of Appeal fined the singer 200 pounds, Given that she had no intention of detention.
- (2) The actress "W.M.", detained her two servants, "M.F" and her sister, "H.F.", inside the bathroom of her residence for about a month, and she and her friends tortured her, then she summoned one of her friends who carried her in a car after they supervised on death and threw them on the way, and one of the maids mentioned that the artist did this after she saw her completely naked in her bedroom with a man other than her husband, so she was afraid to tell him. And she sentenced the artist to ten years in prison, and they were reduced to three years after the appeal in June 2003.
- (3) "Q.S.A.," an officer in the Security Directorate of South Sinai, and his wife, the lawyer "A.H.," tortured their 12-year-old maid, "A.A.A.," where the lawyer stripped the maid of her clothes and ironed them with spoons.

Knives, extinguishing cigarettes in her face, and also burning her with hot water in all parts of her body, at varying intervals, which led, according to reports of doctors and therapists, to a pool of blood in the brain, various burns to the face and limbs, and parts of the skin and scalp fell off. The intensive care room in Al-Demerdash Hospital after many hospitals refused to receive it due to its poor condition. The serving police officer informed the city police station of his residence to issue a report that included hot water falling on the body of the maid while she was taking a shower in an attempt to mislead and cover up the incident. The owner of the service office, who sent the maid to work for this family, stated that he asked the lawyer to take the girl to show her to hospitals before she fell into a coma, but she refused. After presenting the girl to the forensic doctor to determine the type of injuries, he announced the suspicion that the girl had been subjected to rape in addition to torture.

The "Demerdash Hospital Administration" expelled the girl from the hospital and handed her over to her father despite her severe condition, as she was paralyzed in her four limbs and completely lost consciousness.

10/2006 and the date of exit 10/22/2006, while the records and investigations proved that "the entry date is 8/28/2006 and the exit date is 10/30/2006." He accused the officer and his wife of using their influence to expel his daughter from the hospital.

- (4) The 30-year-old H.M.S., a communications engineer at a mobile company in Al-Zaher neighborhood, beat his maid with thick sticks until she died. He heard the screams of his young daughter, so he went to her and found her 9-year-old maid, N.A.A, eating his daughter's food. He wanted to discipline her, grabbed a stick, and beat her until she breathed her last. He was arrested, then he agreed with the housemaid's father to pay his daughter's blood

money of 40,000 pounds to waive the criminal and civil lawsuit, and the housemaid's father accepted this agreement.

- (5) Mrs. H.A.A., 37 years old, killed her Saudi husband, "N.H.A.", 76 years old, and her 18-year-old Indonesian maid, "Nana," when she learned of their association with an illegal relationship, and she sought the help of a son in her crime. Her sister, the 27-year-old driver, M.O.A., who then killed her when she refused to give him a cassette with her voice confessing to having committed the crime on her own. Then he seized a kilo of gold jewelry and an amount of 64,000 Saudi riyals, and he was arrested and referred. For trial, and this incident occurred in the house of the accused in the city of peace.
- (6) The maid Shadia, who is 10 years old, tried to throw herself from the balcony of her employer in Mosadak Street in the Dokki neighborhood to escape from his torture. And that she knew that the maid who used to work for him before had died at his hands because of her frequent torture.
- (7) A woman who lives in the Al-Nuzha neighborhood imprisoned her 15-year-old maid, Dina, and left her. The maid threw herself from the balcony of the house located on the fourth floor, and she fell dead when she was unable to leave the apartment, and the owner of the apartment was seized.
- (8) Each of the 42-year-old woman, "A.M.R.," a housewife, and her husband, a famous businessman in Alexandria, and her brother, "H.M.R.," the 35-year-old, who is a security officer in one of the Zizinia buildings, tortured the maid, "A.M. N., who is 22 years old, where they beat her and ironed her body with an iron, and forced her to sign 4 trust receipts whose value she does not know, because she refused to marry the sister of her employer who was mistreating her, and another maid named "S.M." M., who is 19 years old and works for the same woman. After their arrest, the second maid confirmed that she has been working for this woman and her husband for

three years, and that she had previously tortured her and ironed her body, and they were referred for investigation.

(9) “A.A.,” the 19-year-old who is a car doco maker, “KH,” the 16-year-old, a lathe worker, “A.P.T,” the 16-year-old student, and “A.M.T.,” an armed carpenter, got up. By stealing and raping the maid "F.A" while she was returning from work in one of the houses, where they broke into her room by force, and when she tried to seek help, they threatened to kill her and seized all her money, then forced her to strip naked, raped her, then left her and fled. And they were arrested after the maid identified their descriptions.

(10) Both "A.A.I", 45 years old, and his divorcee, "A.A.A", 43 years old, residing in the United States of America, especially the state of California, brought a 10-year-old Egyptian child to the United States to work as their children's maid, and He forced her to work 16 hours a day and also confiscated her passport, did not allow the child to attend school, and also admitted to beating her at least once, and they confessed to these charges as part of a deal with the federal prosecution, in exchange for her obtaining reduced sentences of three years in prison. A compensation of \$101,000 was paid in favor of the child servant.

(11) The family of an engineer with four daughters beat and tortured their 15-year-old maid "H.S". They tied her hands and feet and tied her to the bed and continued to assault her until she was seriously injured. Gharbia, but they refused her request to recover from her injuries and the effects of torture, and after her recovery, she agreed with them to return to her house so that she could set a date for her wedding, as she was engaged to one of the young men in her village, and her employer gave her 600 pounds, but his 35-year-old daughter took the money from her. And she refused to give it to her, and told her how to marry you, and I do not marry, even though I am

twenty years older than you, and when the maid tried to take her money, the eldest girl informed the police and accused her of stealing her golden chains.

- (12) R.M.A., a 26-year-old house manager who works in the house of the artist, director "T.A.", accused her employer, the director, of assaulting her with insults and beatings, and forcing her to sign a blank security deposit, and the director denied This incident, and he said that this is an attempt by his house manager to blackmail him, as he had previously issued a report to her at the "Nasr City" police station, accusing her of stealing an amount of money and some belongings from his house, and she is trying to bargain with him to drop the report.
- (13) "A.P.A.," the 53-year-old who is a real estate guard, killed his wife, the 36-year-old maid, "A.A.A.," because he suspected her behavior with the owners of the houses in which she served, so he prepared a knife and stabbed her after A quarrel between them, and the court sentenced him to 10 years imprisonment.
- (14) "A.A." raped his 15-year-old maid "A.A." He gave her a cup of tea and put him to sleep, and after he saw his maid sitting on her knees while she was performing her work in cleaning the apartment, and after he made sure of her absence Unconsciously, he sexually assaulted her, and the maid did not discover that she was pregnant until four months later when her mother took her to the doctor because she felt unwell.
- (15) A 68-year-old woman tortured her maid who worked for her in her house in the Al-Agouza neighborhood until she died, as she used to beat her, so she tortured her to death, and the maid was arrested and she confessed to beating the victim for stealing food and denied the murder charge The maid's daughter confirmed that her mother beat the maid with some cooking utensils about 12 days ago, and after that she fell into continuous fainting.

- (16) The 18-year-old maid committed suicide by jumping from the balcony of her employer's apartment on the eighth floor in Real Estate No. 115, Al-Fath Street, Al-Raml Police Station, because of her father's insistence that she leave work and return home.
- (17) A woman, her son, and her daughter tortured their Thai maid, because they suspected that she had stolen a ring and a diamond ring from her maid's bedroom, where they detained her in one of the rooms of the house in the Zamalek neighborhood in Cairo, and they tied her up and tortured her for a whole week by beating her with whips and a wooden stick until she breathed her last as a result of the torture. The Cairo Criminal Court ruled that the mother be punished with imprisonment for a period of 5 years, and that each of them be punished with imprisonment for one year, with a suspension of execution for a period of 3 years.
- (18) A 43-year-old butcher accused his maid of stealing an amount of 470 thousand pounds from his house in Alexandria, but the investigations of the Criminal Investigation Department revealed that it was the wife of the victim (the butcher) who stole the amount, in retaliation for his refusal to her pregnancy for fear of knowing his first wife, so she stole the amount from the treasury, and the maid was accused of theft, and the Public Prosecution office launched an investigation.
- (19) Four unemployed people in the village of Al-Falaj, Al-Khanka Center, Al-Qalyubia Governorate, kidnapped a 13-year-old maid and assaulted her at gunpoint for three days. The maid had escaped from her family's house in Tanta to the Heliopolis district in Cairo, where she met her lady and asked her to work for her as a maid. Then she fled from her employer's house because of her mistreatment, to the Misr station to return to Tanta. While waiting for the train, she met a young man who took her to the village of Al-

Falaj to sleep with his sister in his family's home. When he arrived, he summoned three other people from his friends and stripped her of her clothes at gunpoint and took turns assaulting her for three days, then she managed to escape from them and went to the investigations of Al-Khanka Center and filed a report against them. The accused were arrested and confessed to having committed the incident, so the Public Prosecution ordered them to be imprisoned and the victim transferred to forensic medicine.

(20) A woman residing in Alexandria tortured her maid, called Safaa, at the age of 21, because she suspected that she had stolen her golden necklace, so she tied her up with the help of her neighbor and beat her for a whole day with a carabiner until she confesses to herself and tells her the location of the necklace, and when the maid refused to confess, the lady and her husband beat her for 10 hours continuously with a hammer on her head, then they extinguished the cigarettes in her breasts until she lost consciousness, then they threw her among the piles of rubbish and gave one of the scavengers money to take her to the hospital, and the scavenger took her to Alexandria University Hospital. Breasts and bruises in all parts of her body.

(21) A businesswoman took her 14-year-old maid, Hind, in her car to meet a person in a casino who said he was her lover. The maid was locked inside the car until she finished the interview, and the business lady got busy, and she forgot the maid who had asked passers-by to get her out of the car, to no avail, until she suffocated inside the car and was killed.
